The FALL School Age Day Care is a day care program designed to serve Mt Calvary families who need supervision for their children while they work, and their child attends school on-line. All children registered for school at MCL ages 5 to 14 years of age are invited to attend.

Registration: Because your child is already enrolled at MCL, there is no additional registration fee, all that is needed to sign up is for parents to fill out the Registration Form **by August 24th** indicating your intent to participate.

- Academic support for students as they do their work
- Monitoring of behavior by SAC Staff so they stay on task
- Supervision during recess and lunch breaks
- Additional child care support beyond school hours at no extra cost

PROGRAM GUIDELINES and INFORMATION

Read and check all the following:

- I understand that Mt. Calvary Day Care fees are to be paid weekly, and agree to that my child(ren) and I will abide by all the policies and guidelines and follow all schedules.
- I understand that students may be organized into small study groups.
- I understand that all food, lunch, and snacks need to be brought from home and that MCL will not be providing any food or beverages.
- I give Mt Calvary Church & School permission to use my child's photograph or video image to promote the Fall Day Care program.
- I understand that temperatures will be taken upon arrival and recorded. Any child with a temperature of 100.4 or higher will not be admitted for day care that day and will only be allowed back upon the discretion of the SAC Director or School Principal.
- I understand that if any case of Covid-19 is contracted by any of the families or staff in attendance, MCL will follow the Health Department's recommendations in regards to closure.
- My child/children are physically fit and able to participate and will commit to being part of the Mt. Calvary Day Care service provided during this unique time of Covid-19.
- I am aware that activity does pose risk of injury, and that occasionally accidents do happen. I agree to assume all risks associated with participation in day care activities. I understand that MCL will do its best to lessen the spread of germs by sanitizing often, keeping separate and small groups, and teaching children proper etiquette, but there is no guarantee that we can remain germ free.
- I agree to release Mt. Calvary Lutheran Church and School, Mt. Calvary Day Care, and any and all members of its governing boards of any responsibility for the health, safety and well-being of the child/children named above, beyond such matters as may be called reasonable care for children in the custody of a staff person and subject to their clear instructions, and assumes personally and exclusively all responsibility and liability for accident or injury, which may occur to the above named child/children during the MCL 2020 Fall Day Care program.
- In the event of a medical emergency, I authorize medical personnel attending to my child, to make decisions regarding immediate medical treatment as may be necessary until such time I can be consulted.
