School Age Care (SAC) Full Year Agreement 2024-2025

To assist families with monetary commitments and financial planning, to provide greater efficiency for School Age Care staff planning and coordination and to provide consistent care and supervision of regular attendees to the School Age Care program, Mt. Calvary offers the following contractual annual agreement for the school year **2024-2025 starting on 8/12/24 and ending on 5/22/25.**

- 1. This contract covers school age care fees, exclusive of registration or special fees, for families who commit to full-time, monthly care of their students as part of the Mt. Calvary Lutheran Church and School for the before and after school care program.
- Families must commit to a monthly fee of: \$360 for 1 child, \$650 for 2 children, or \$885 for 3 children that will be a "flat fee" available for all hours of operation of the School Age Care Program during the regular school term. This includes both morning and afternoon, if necessary, but is not reduced by non-attendance to either time. Attendance to all hours is not required to receive the discounted fee.
- 3. This fee is not dependent on the number of hours attended and cannot be reduced or refunded for less than full-time attendance. Less than full-time attendance, once agreed upon, will require the same \$340 monthly fee as this is a contracted amount, not negotiable or related to time of attendance.
- 4. No other discounts or fee reductions are available with this special reduced monthly fee.
- The family of the attending student agrees to contract for the special fee for the entire school year, August to May (10 full months) <u>No reimbursements for cancellation or partial months are allowed.</u>
- 6. Payments must be made with automated payments through the Tuition Authorization Form via Simply Giving each month.
- 7. Failure to provide monthly payments as stipulated will remove the attending child or children from the special discount program, apply cancellation fees of \$500, apply late fee penalties and return attending students to regular hourly fees for time attendance. You will be charged retroactive fees at the regular rate for time of attendance.
- 8. Agreement to this discounted rate is a contractual agreement for the entire school year and excludes Summer Program rates.
- 9. Minimum Days, Regular Scheduled Vacations (Thanksgiving, Christmas and Easter) are included in the monthly fee for each student. (Vacation days are subject to closing depending on minimum sign ups)

By signing this agreement, I agree to pay \$360 for 1 child, \$650 for 2 children, or \$885 for 3 children on the first of each month or with tuition payments through Simply Giving to Mt. Calvary Lutheran Church and School. I further agree that the fees will not be dependent on the number of hours of attendance as this is a full-time coverage fee, regardless of actual number of hours of child attendance.
